














Fig 6. Reverse current as a function of reverse voltage; typical values


Fig 7. Diode capacitance as a function of reverse voltage; typical values


Fig 8. Average forward power dissipation as a function of average forward current; typical values

- (4) $\delta = 0.5$


Fig 9. Average reverse power dissipation as a function of reverse voltage; typical values

- (4) $\delta = 0.1$; f = 20 kHz


Fig 10. Average forward current as a function of ambient temperature; typical values


Fig 11. Average forward current as a function of ambient temperature; typical values

Fig 12. Average forward current as a function of ambient temperature; typical values






